DRAFT RESOLUTION ON

**THE ADOPTION OF THE REPORT OF THE MEETING OF THE
COORDINATING COMMITTEE OF WOMEN PARLIAMENTARIANS
OF AIPA (WAIPA)**

The Forty-Third AIPA General Assembly:

Recalling the Resolution 19WC-GA/W/98/01 on the *Formation of the Women Parliamentarians of AIPO*, Resolution 19WC-GA/W/98/02 on *Rules of Procedure of Women Parliamentarians of AIPO*, and Resolution RES.37GA/2016/ WAIPA/01 on the *Amendments to the Rules of Procedure of Women Parliamentarians of AIPO*;

Noting that Women Parliamentarians of AIPA is the only standing committee that has its own rules of procedure (RoP), regulating how WAIPA must operate to carry out its functions;

Bearing in mind that the current RoP of WAIPA regulates the terms of office of the Chairperson and Vice Chairperson of WAIPA, as well as the implementation of the meeting of the Coordinating Committee which precedes the WAIPA Committee meeting during the General Assembly;

Recognizing that the meeting of the Coordinating Committee of WAIPA was held via videoconference on 30 August 2022 to discuss the “*Roles of Parliaments in Promoting Gender-responsive Recovery from the COVID-19 Pandemic*” and “*Roles of Parliaments in Advancing Women, Peace and Security Agenda*”;

Taking note that one of the objectives of the meeting of the Coordinating Committee is to solicit inputs from AIPA Member Parliaments for the Draft Resolutions to be tabled at the WAIPA Committee of the 43rd AIPA General Assembly;

Commending the hosting of the meeting of the Coordinating Committee of WAIPA by the National Assembly of the Kingdom of Cambodia;

Expressing great appreciation to the Coordinating Committee of WAIPA for their valuable contribution towards the development and growth of WAIPA as a platform to encourage women's participation in decision-making processes at the regional level.

Hereby Resolves to:

Adopt the Report of the meeting of the Coordinating Committee of WAIPA chaired by Hon. Kittisahangkbindit Khuon Sudary, Vice President of the National Assembly of the Kingdom of Cambodia, on 30 August 2022 via videoconference.
